- 1. You are not meeting the financial aid completion rate and/or GPA requirements.
- 2. You are returning to college after not attending (any college) for an extended period of time.
- 3. It is mathematically possible for you to reach a cumulative 2.0 GPA and cumulative 67% completion rate within the maximum allowed time frame of 96 total attempted credit hours.

If you meet these criteria and wish to request an Academic Plan of Improvement and Eligibility Reinstatement, please complete this form and return it to the Redlands Community College Financial Aid Office along with:
